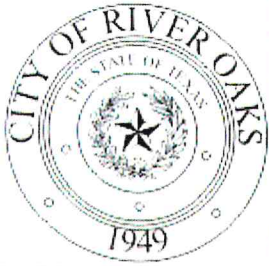

**8.
