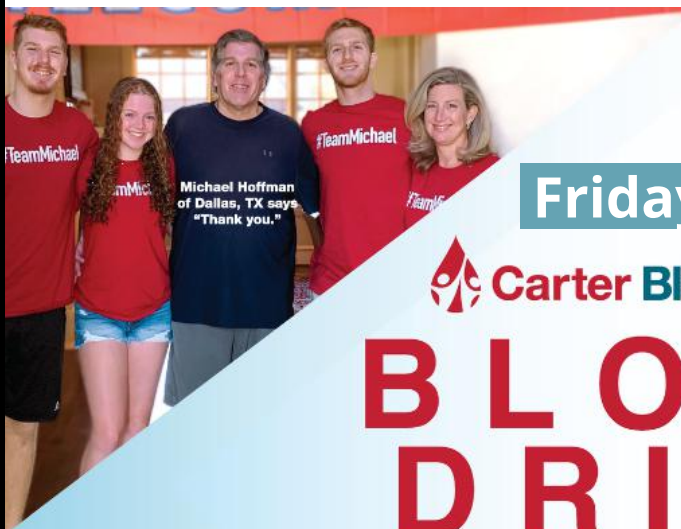

**A Public Hearing is scheduled before the River Oaks Planning & Zoning Commission on Thursday, June 30, 2022 at 6:30 P.M. and a final public hearing before the River Oaks City Council on Tuesday, July 12, 2022 at 7:00 P.M. in the City Council Chambers located at 4900 River Oaks Blvd., River Oaks, Texas in order to receive citizen comments on the proposed re-plat application in the Saint Elizabeth's Subdivision being 3.95 acres of Land situated in the Nathaniel H. REQUEST FOR DELAY OF BILL PAYMENT DATE FOR DISABLED INDIVIDUALS

The River Oaks Mayor and City Council have passed an ordinance waiving the late fees for disabled individuals.

GENERAL: Pursuant to the City of River Oaks Ordinance Section 13.02.045 "Delay of Bill Payment Date for Disabled Individual", upon the request by a disabled individual, a utility shall delay without penalty the payment date of a utility bill for providing utility service for that disabled individual until after the 25th day after the bill is issued. Disabled Individuals under this section of the delay of bill procedures under this section means an individual that is authorized by the Federal Social Security Administration.

This applies to Disabled Individuals who:

1. are a residential water customer; and
2. Occupies the entire premises for which the delay is requested.

REQUEST FOR DELAY: A disabled individual may request that the utility implement the delay pursuant to Ordinance section 13.02.045 for the most recent utility bill; or for the most recent utility bill and each subsequent utility bill.

PROOF OF DISABLED STATUS: A customer's disabled status must be verified by an Award Letter from the Social Security Administration.

ORDINANCE NO. 1339-2022

AN ORDINANCE AMENDING THE RIVER OAKS CODE OF ORDINANCES, CHAPTER 8, "OFFENSES AND NUISANCES," ARTICLE 8.07 "PETS INSIDE MUNICIPAL BUILDINGS"

Sec. 8.07.002 Prohibitions

(a) Pets are prohibited and are not allowed access into municipal buildings where a sign or notice is clearly posted on the building, reading "No pets allowed, trained service animals only."

(b) When a person seeks to be admitted to a Municipal building with a service animal or assistance animal, to determine whether a dog is a service animal or assistance animal, a staff member or City manager may only inquire:

- whether the service animal or assistance animal is required because of a disability; and
- what work or task the service animal or assistance animal has been trained to perform.

(c) Any person or persons bringing or carrying pets inside municipal buildings where notice is posted as required by this Section is in violation of this section and is subject to penalties as provided in this Code, Section 1.01.009.

Please stay in your vehicle, this is a drive thru food bank.

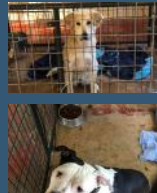
