CONSIDER APPROVAL OF **ORDINANCE** # 1164-2017 AMENDING SECTION 12.05.013 "SPECIAL TIME LIMIT NO PARKING ZONES" OF THE RIVER OAKS CODE OF ORDINANCES AS AMENDED BY DESIGNATING A TIME LIMITED PARKING ZONE BETWEEN THE HOURS OF 10:00 P.M AND 6:00 A.M.
