





- 7. **PUBLIC HEARING:** TO RECEIVE PUBLIC INPUT ON THE PROPOSED 2017-2018 FISCAL YEAR OPERATING BUDGETS FOR THE CITY OF RIVER OAKS.
- 8. **ACTION FROM PUBLIC HEARING**: CONSIDER APPROVAL OF **ORDINANCE** # <u>1162-</u>2017 ADOPTING THE RIVER OAKS OPERATING BUDGETS FOR THE PERIOD OCTOBER 1, 2017 THROUGH SEPTEMBER 30, 2018.
